

# COVID-19 Testing: Drive Thru Testing Facility (CHCO-Anschutz Campus)

## COVID-19 Testing Information at Children's Hospital Colorado (Anschutz Campus)

- Location: 1575 Wheeling Street, Aurora, CO 80045
- Hours of operation: 7 days/week 7 a.m. – 5 p.m.
- **Testing is by appointment only.** Nasal pharyngeal PCR specimens are collected, no blood or serology.
  - Specimens collected at a provider's office cannot be dropped off at the drive thru site and instead should be routed to the Lab via a courier service for processing.
  - Orders can be placed via Children's CO Connect, PedsConnect, via fax (720-777-7903) or via email to [RegistrationLabCOVID@childrenscolorado.org](mailto:RegistrationLabCOVID@childrenscolorado.org)
  - Call **720-777-0001** to schedule your appointment.
  - Maternal Fetal Medicine patients do not need to call for appointment. Please see below.
- This is a drive through site. Note: Vehicles taller than 8 feet will not fit inside the building
  - If you do not have a vehicle, you can walk-up to the site. Please tell the team member at the gate that you are a walk-up patient.
- We will not collect any co-pays. We will bill your insurance if you have it.

### Pre-Procedural

- Schedule test within three (3) calendar days of procedure or surgery, no later than 11 am the day prior to procedure or surgery. Patient and family members should self-isolate from time of specimen collection until procedure. Only tests performed at CHCO are accepted.

### Maternal Fetal Medicine

- The Maternal Fetal Care Nurse will call to notify you of your scheduled appointment time.

### Symptomatic Parent/Guardian or Partner/Spouse of Patient Currently Hospitalized at CHCO

- Bring your order with you to the appointment
  - We require a negative result for COVID-19 before allowing you to visit your child/spouse.

### Healthcare Worker and Community Provider Requested Test

- Referral from Occupational Health or Provider required when scheduling appointment
- Referrals must be submitted via one of the following:
  - Sent ahead via email to [RegistrationLabCOVID@childrenscolorado.org](mailto:RegistrationLabCOVID@childrenscolorado.org)
  - Sent ahead via fax to 720-777-7903
  - Providers with PedsConnect or Children's Colorado Connect access can order & schedule patient test appointments
  - Shown in person at time of appointment (i.e., a photo of the referral on your smart phone)
